If you are bringing a firearm, THERE IS NO LIVE **AMMO** IN CLASS! After class time (3 to 4 hrs.), we will break for lunch. You can brown bag or stop on the way to the range. (about 20 mins) The range is **an old gravel pit** used for shooting. (**conditions are rough at best**) Once at range we all shoot both **bench and standing** positions. After we get our fill of live fire, we return to field strip and clean whatever firearm you used. Please remember class is a **FULL DAY**, but a fun day.

WE SHOOT OUTDOORS SO DRESS FOR THE WEATHER, CLOSED TOE SHOES ARE SUGGESTED. WE SHOOT RAIN OR SHINE, WE ONLY STOP FOR HEAVY RAINS OR STORMS. (we reschedule if need be.)

Remember everyone needs to bring hearing and eye protection. For those bringing a firearm, bring the manual.

RELEASE WAIVER, INDEMNIFICATION, HOLD HARMLESS AND ASSUMPTION OF RISK AGREEMENT

WHEREAS, in return for use of the premises, firearms, classroom and facilities, use of outdoor/indoor range and other amenities and for good and valuable consideration, the receipt of which is hereby acknowledged, the Undersigned agrees to the following:

The undersigned agrees to hold harmless and defend ALL CALIBERS FIREARMS TRAINING/RANGE AND FIELD TRAINING TEAM(herein known as the team)and any property owners and heirs, Instructors Tom Yackley, Dave Phistry assigned firearms instructors, staff, directors officers and agents from any and all fault, liabilities, cost, expense, claims demands or law suits, arising out of, related to or connected with: the discharge of firearms, any course of instruction, use of classroom facilities or any other facilities existing on or off the premises, the firing range, buildings, land and premises or any other activity(hereafter PREMISES) , the undersigned's presence on or use of said premises and any and all omissions of the undersigned. AND should any such claim, demand or lawsuit arise or be asserted in any way whatsoever related thereto, whether arising under the laws of the United States or of any State or under theory of law or equity, the Undersigned will, indemnify, hold harmless and defend the Team and any listed above from any and all costs, expenses or liability including, but not limited to, the cost of any settlement or judgment made or rendered against the Team and others listed whether individually, jointly, or in solido with the Undersigned the Undersigned together with all costs of court and other costs or expense incurred in connection with any such claim, demand lawsuit, including attorney's fees.

The undersigned furthermore waives for himself/herself and his/hers executors, administrators, assignees or heirs any and all rights and claims for damages, losses demands and any other actions whatsoever, which he/she may have or which may arise against the Team and others listed above,(including but not limited to any and all injuries, damages, illness or death suffered by the Undersigned or property of the undersigned)which may in any way whatsoever arise out of, be related to or be connected with: The course of firearm instruction, Premises, including any latent defect in the premises, the undersigned's presence on or use of such said premises. The Undersigned's property (whether or not entrusted to the Team or others listed above), and the discharge of firearms. The undersigned agrees. On behalf of himself/herself and his/her executors, administrators assignees or heirs, herby releases the Team and others listed above from any and all such claims.

The Undersigned hereby assumes the risk of entering the premises and of taking part in activities on premises which includes but are not limited to: instruction in the use of firearms, use of firearms, discharge of firearms, firing of live ammunition, maintenance work, upkeep, repairs and construction.

The Undersigned has current coverage of medical, health and life insurance to cover any and all claims and losses that may occur on or about the Team. Furthermore, if the undersigned is pregnant or a nursing mother, A doctor's signed certificate for participation will be provided prior to starting any class.

The Undersigned furthermore hereby acknowledges and agrees that he/she has read, understands and will at all times abide by all the Team's – and others listed above – policies, procedures, range rules and guidelines- especially, firearm safety.

This instrument binds the Undersigned and his/her executors, administrators, assignees or heirs.

RELEASE WAIVER, INDEMNIFICATION, HOLD HARMLESS AND ASSUMPTION OF RISK AGREEMENT

In the case of FIREARMS SAFETY VIOLATIONS, there will be no discussion or exceptions. All judgments and decisions made by instructors and range officers are final and are NOT subject to review.

The undersigned also understands that, if at any time during their participation in activities, the undersigned points an UNLOADED gun at any person or part of a person- including the undersigned- one warning will be issued. The undersigned may continue in the activity, but will not be allowed any live ammunition. The undersigned has the right to leave the activity with NO REFUND or activity may be completed using dummy ammunition or an unloaded firearm. However, due to the violation of firearms safety protocol, undersigned will not receive credit for completing the activity. If a second violation of firearms safety protocol with an unloaded firearm occurs, undersigned will be immediately dismissed from the activity and NO REFUND will be given.

The undersigned also understands that, if at any time during their participation in activities, the undersigned points a LOADED FIREARM at any person or part of a person- including the undersigned- NO warning will be given. The undersigned will immediately under the direction of an instructor or range officer, unload their firearm, case it and be dismissed for the premises. There will be NO REFUND.

Physical disabilities in and of themselves are NOT reason for being unable to participate. However, if the disability prevents the undersigned from SAFELY HANDLING a firearm, the UNDERSIGNED WILL NOT BE ALLOWED TO CONTINUE IN THE ACTIVITY OR RECEIVE CERTIFICATE OF COMPLETION.

The undersigned expressly agrees that this instrument is intended to be as broad and inclusive as permitted by law, and that if any provision of this instrument is held invalid or otherwise unenforceable, the enforceability of the remaining provisions shall not be impaired thereby. No remedy conferred by any of the specific provisions of this instrument is intended to be exclusive of any other remedy, and each and every remedy shall be cumulative and shall be in addition to every other remedy now and hereafter existing at law or equity or by statute or otherwise. The election of any one or more remedy hereunder by the Team or Instructor shall not constitute any waiver of Team or Instructor's right to pursue other available remedies. This instrument binds the Undersigned and his/her executors' personal representatives, administrators, assignees heirs and next of kin.
